




Figure 1. Max. Average Forward Current vs.
Ambient Temperature




Figure 2. Typ. Forward Current vs. Forward Voltage




Figure 3. Max. Peak Forward Surge Current vs. Number of Cycles




Figure 4. Typ. Diode Capacitance vs. Reverse Voltage




Figure 5. Typ. Reverse Current vs. Percent of Rated Peak Reverse Voltage



#### **Ozone Depleting Substances Policy Statement**

- 1. Meet all present and future national and international statutory requirements.

- 2. Class I and II ozone depleting substances in the Clean Air Act Amendments of 1990 by the Environmental Protection Agency (EPA) in the USA
- 3. Council Decision 88/540/EEC and 91/690/EEC Annex A, B and C (transitional substances) respectively.
