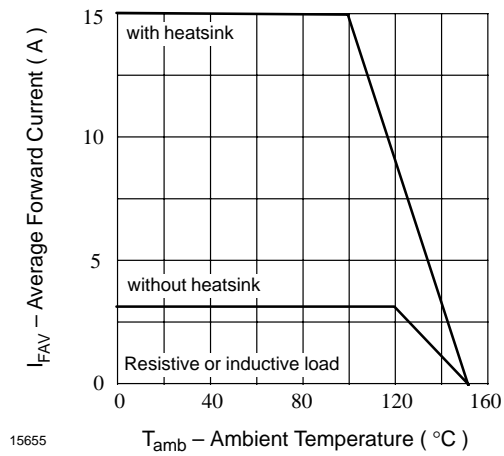

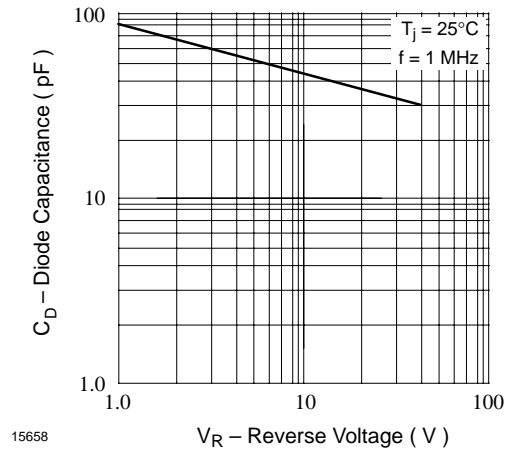

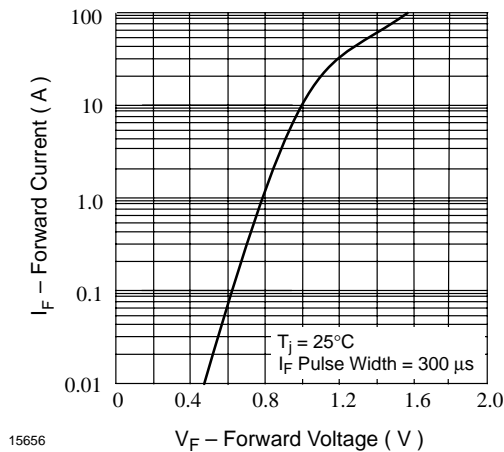

Figure 1. Max. Average Forward Current vs. Ambient Temperature



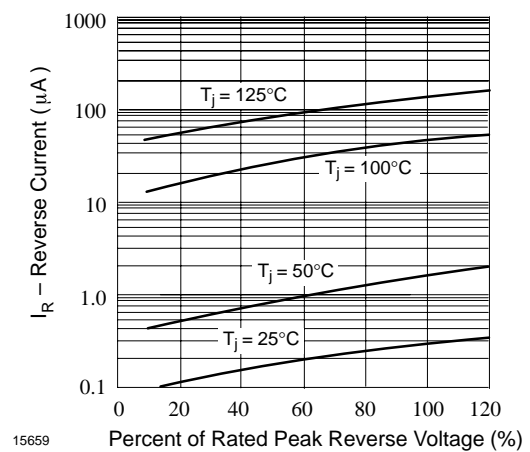

Figure 4. Typ. Diode Capacitance vs. Reverse Voltage



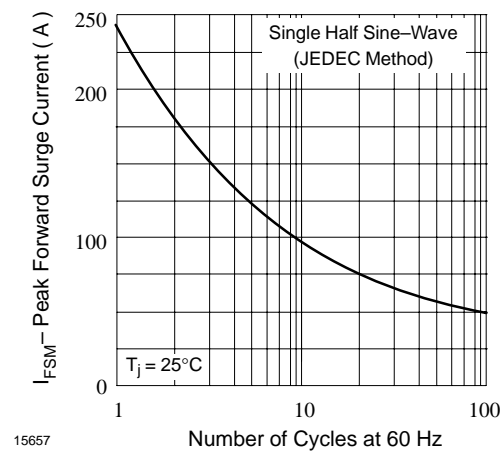

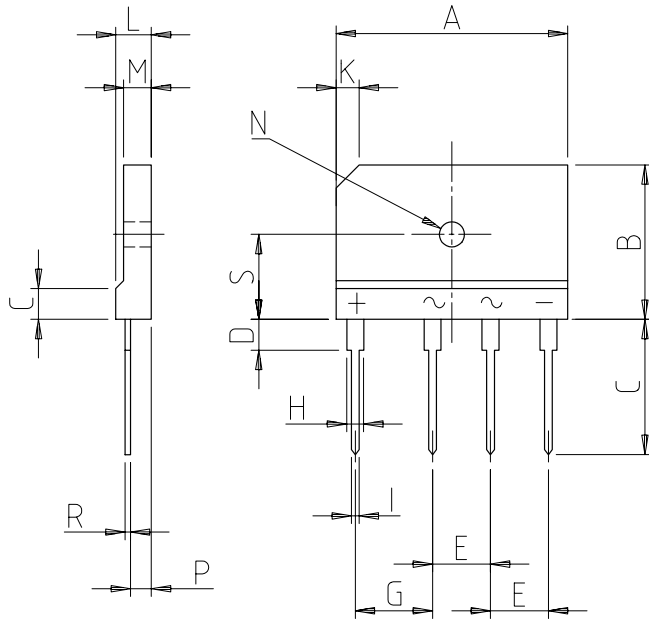
Figure 3. Max. Peak Forward Surge Current vs. Number of Cycles



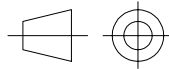
