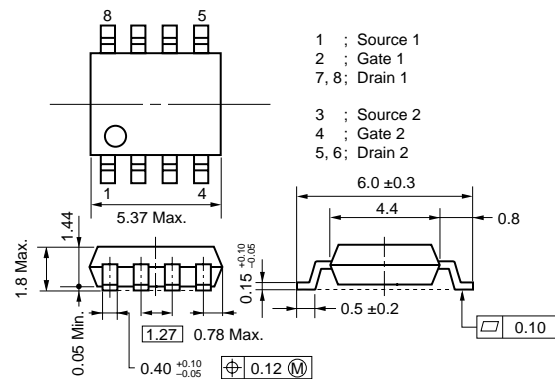
#### DESCRIPTION

The  $\mu$ PA2753GR is Dual N-Channel MOS Field Effect Transistor designed for DC/DC converters and power management applications of notebook computers.

#### PACKAGE DRAWING (Unit: mm)



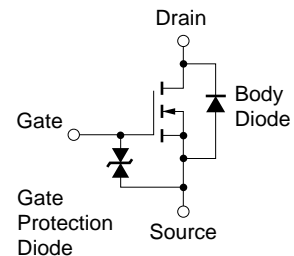

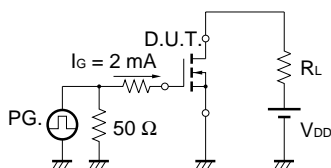
**TEST CIRCUIT 1 AVALANCHE CAPABILITY**



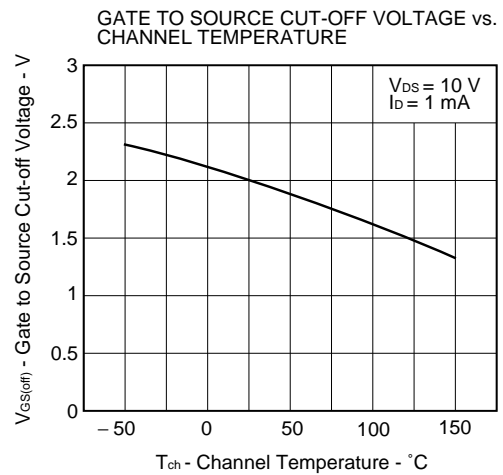
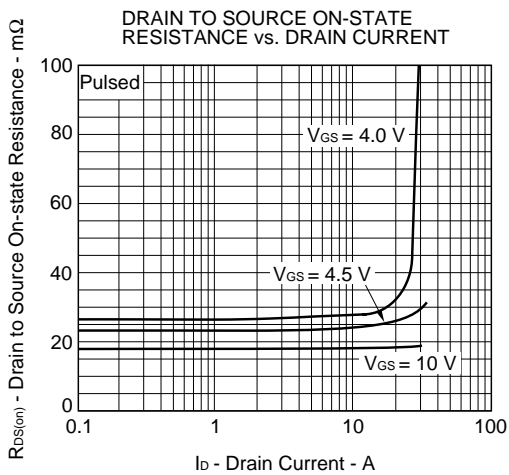
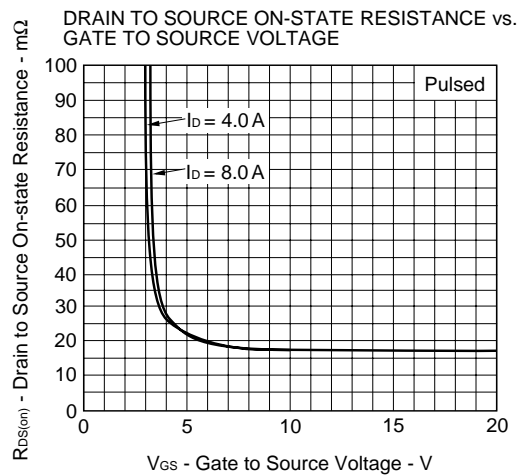
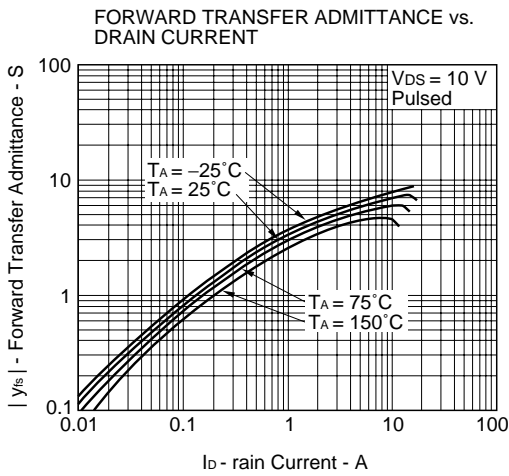
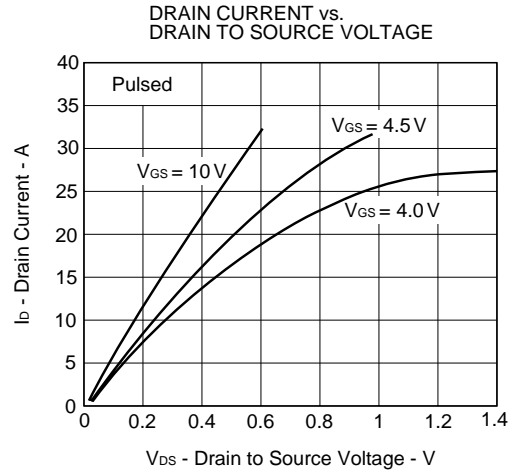
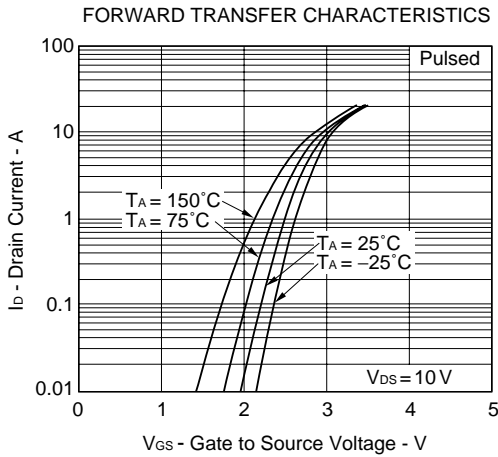
**TEST CIRCUIT 2 SWITCHING TIME**

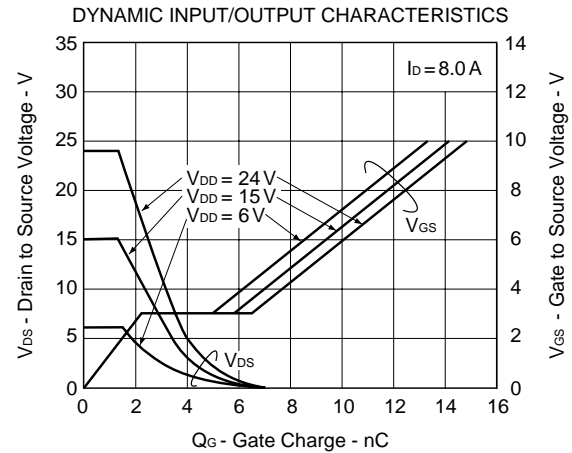
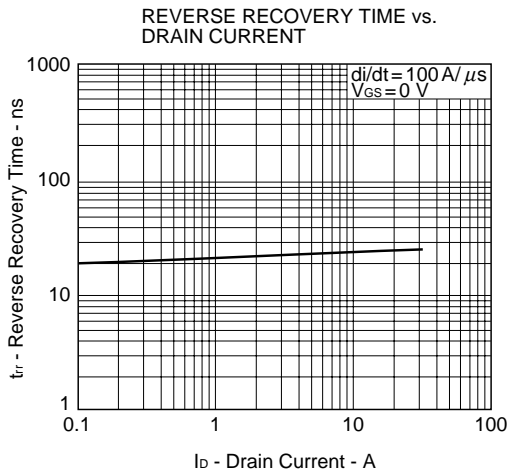
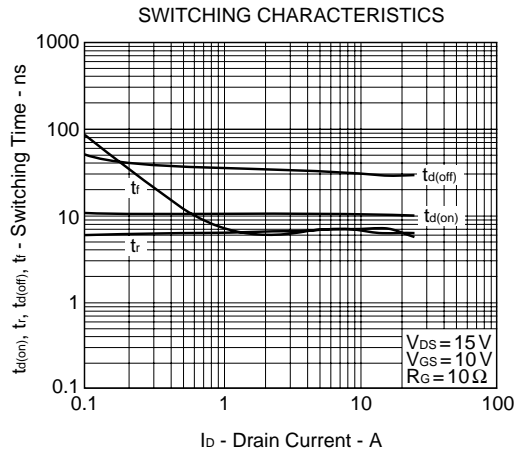
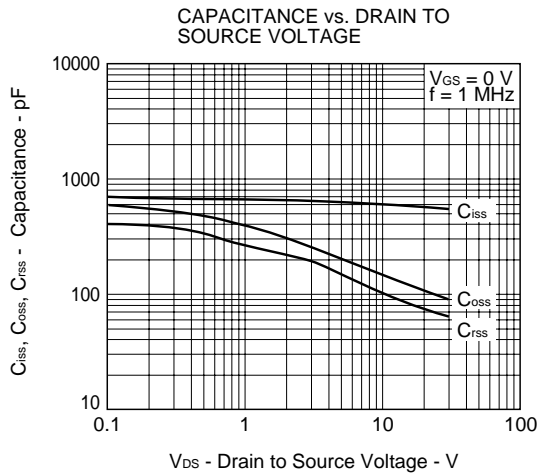
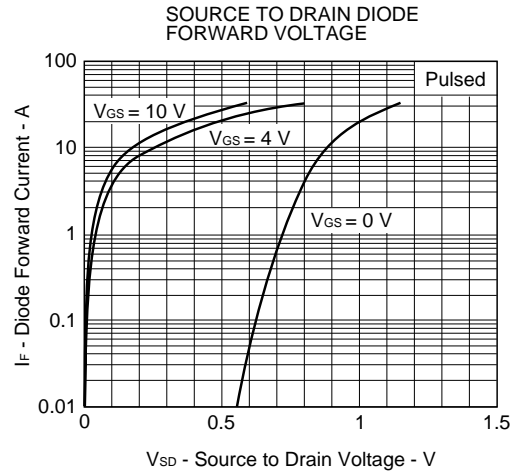
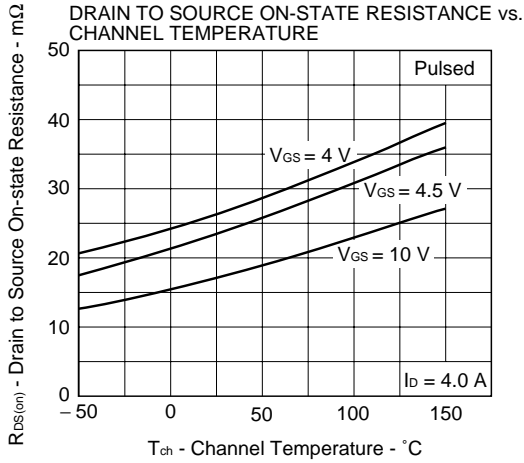


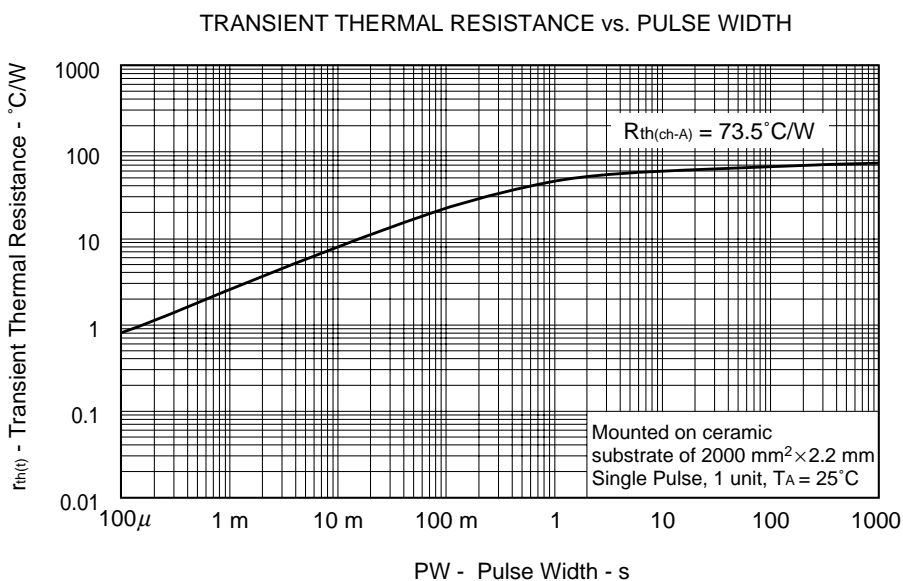
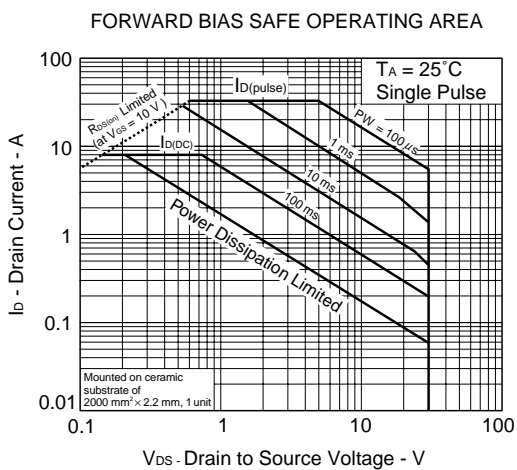
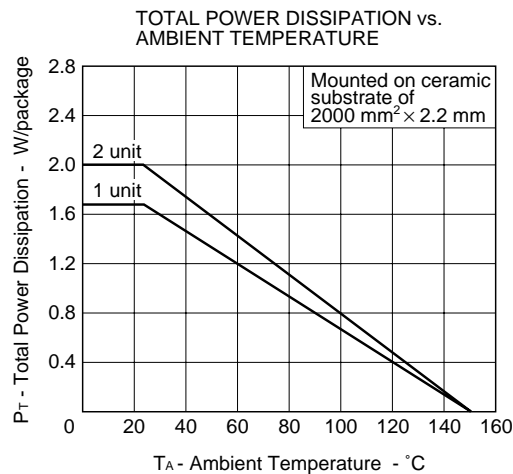
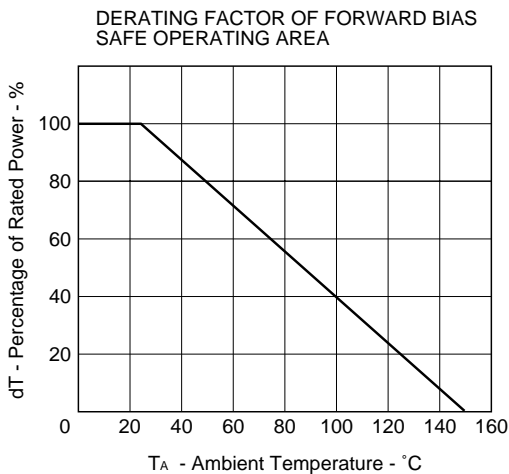
**TEST CIRCUIT 3 GATE CHARGE**

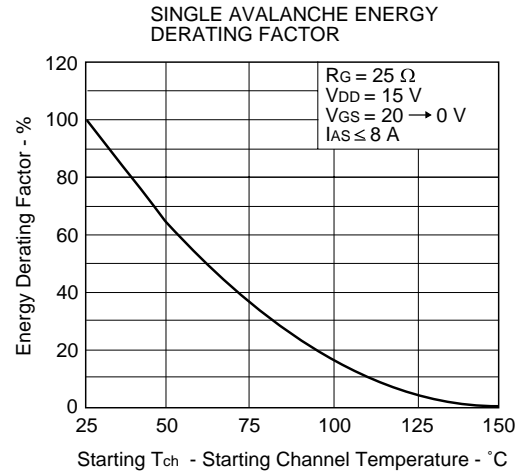
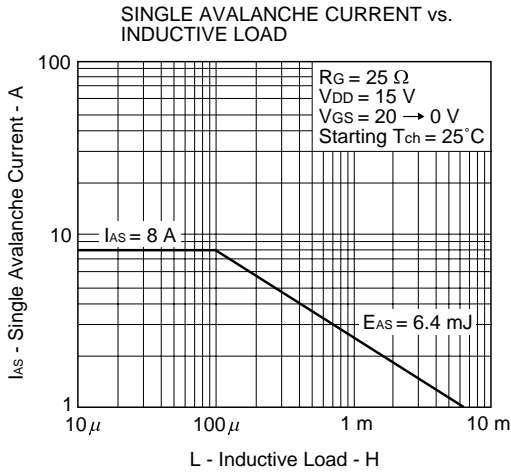
