

## Low power dual voltage comparators

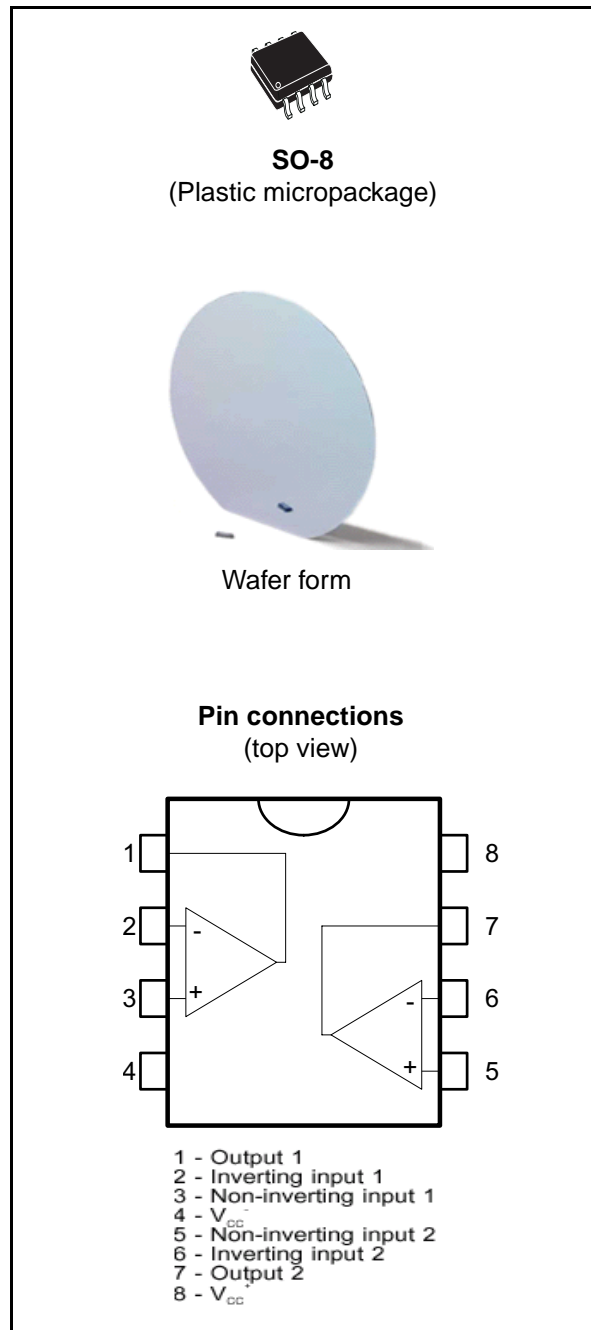
### Features

- Wide single supply voltage range or dual supplies +2 V to +36 V or  $\pm 1$  V to  $\pm 18$  V
- Very low supply current (0.4 mA) independent of supply voltage (1 mW/comparator at +5 V)
- Low input bias current: 25 nA typ.
- Low input offset current:  $\pm 5$  nA typ.
- Input common-mode voltage range includes ground
- Low output saturation voltage: 250 mV typ. ( $I_O = 4$  mA)
- Differential input voltage range equal to the supply voltage
- TTL, DTL, ECL, MOS, CMOS compatible outputs

### Description

This device consists of two independent low power voltage comparators designed specifically to operate from a single supply over a wide range of voltages. Operation from split power supplies is also possible.

These comparators also have a unique characteristic in that the input common-mode voltage range includes ground even though operated from a single power supply voltage.

- Short-circuit from the output to  $V_{CC}^+$  can cause excessive heating and eventual destruction. The maximum output current is approximately 20 mA, independent of the magnitude of  $V_{CC}^+$ .
- Short-circuits can cause excessive heating and destructive dissipation. Values are typical.
- Human body model: A 100 pF capacitor is charged to the specified voltage, then discharged through a 1.5 kΩ resistor between two pins of the device. This is done for all couples of connected pin combinations while the other pins are floating.
- Machine model: A 200 pF capacitor is charged to the specified voltage, then discharged directly between two pins of the device with no external series resistor (internal resistor < 5 Ω). This is done for all couples of connected pin combinations while the other pins are floating.
- Charged device model: all pins and the package are charged together to the specified voltage and then discharged directly to the ground through only one pin. This is done for all pins.

- The input common-mode voltage of either input signal voltage should not be allowed to go negative by more than 0.3 V. The upper end of the common-mode voltage range is  $V_{CC}^+ - 1.5$  V, but either or both inputs can go to +30 V without damage.

Figure 1. Schematic diagram (1/2 LM2903)

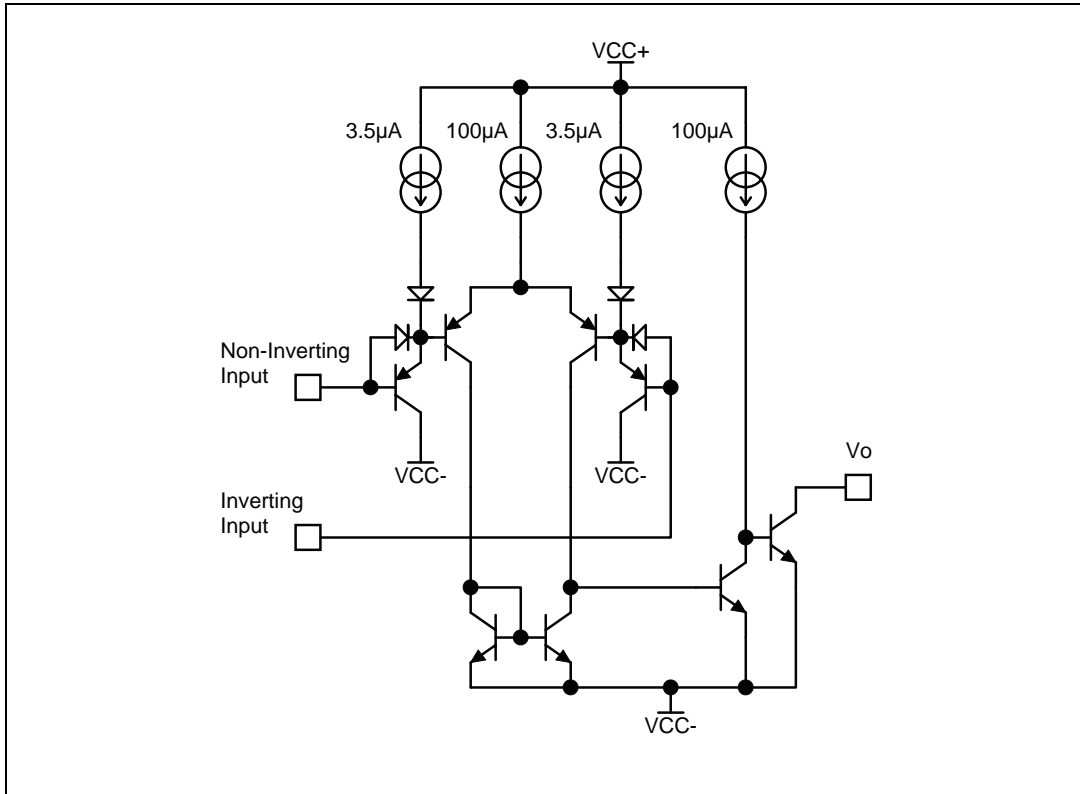
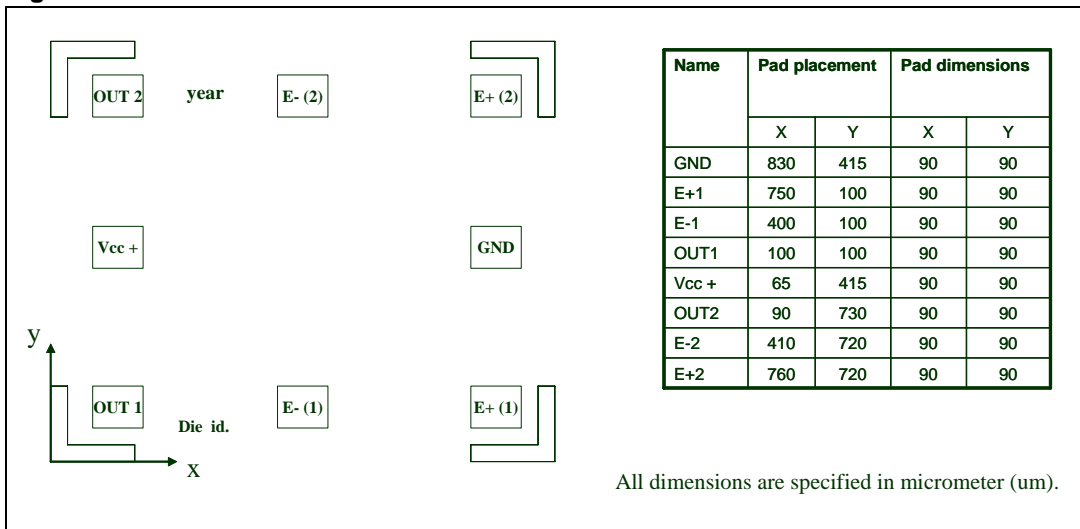


Figure 2. Pad locations

1. At output switch point,  $V_o \approx 1.4V$ ,  $R_S = 0\Omega$  with  $V_{CC}^+$  from 5V to 30V, and over the full input common-mode range (0V to  $V_{CC}^+ - 1.5V$ ).
2. The direction of the input current is out of the IC due to the PNP input stage. This current is essentially constant, independent of the state of the output, so there is no load charge on the reference of input lines.
3. Positive excursions of input voltage may exceed the power supply level. As long as the other voltage remains within the common-mode range, the comparator will provide a proper output state.  
The low input voltage state must not be less than  $-0.3V$  (or  $0.3V$  below the negative power supply, if used)
4. The response time specified is for a 100mV input step with 5mV overdrive.
5. Maximum values are guaranteed by design and evaluation.

Figure 3. Supply current vs. supply voltage

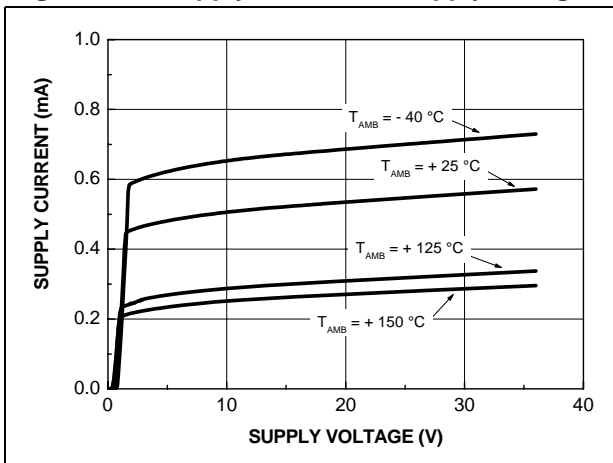


Figure 4. Input current vs. supply voltage

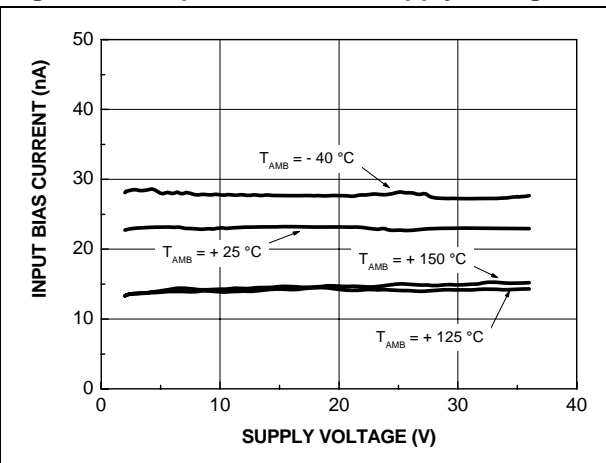


Figure 5. Output saturation voltage vs. output current ( $V_{CC}=5V$ )

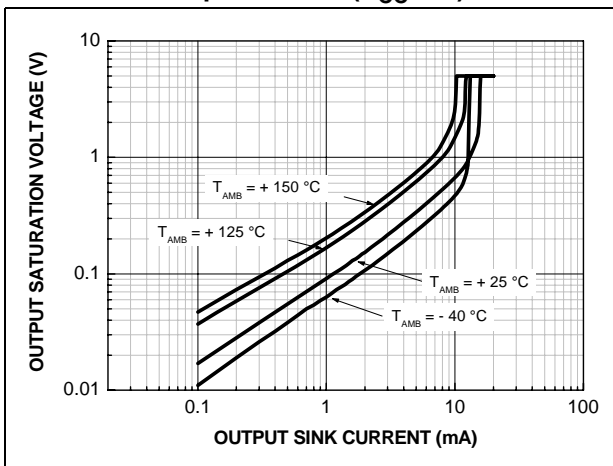


Figure 6. Response time for various input overdrives - negative transition

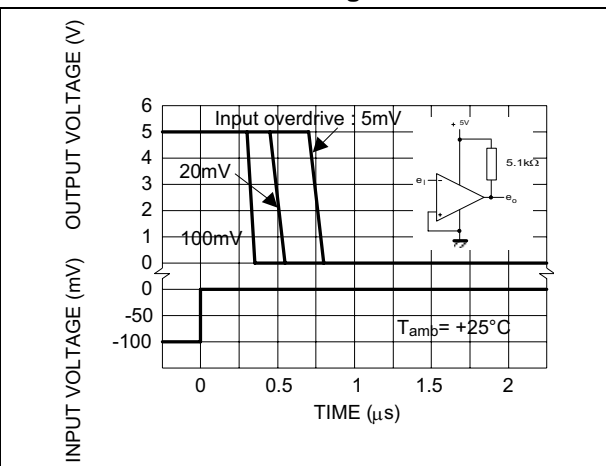
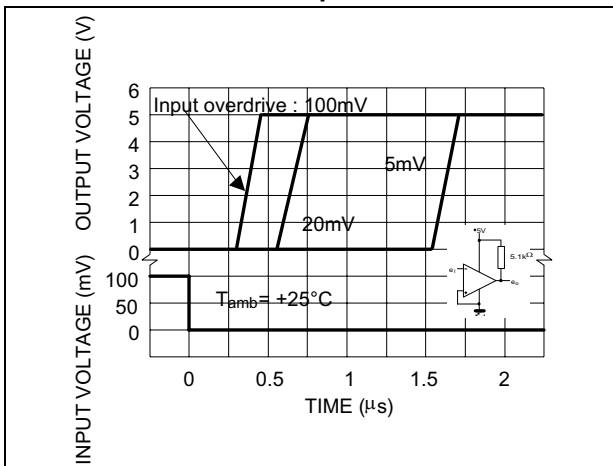


Figure 7. Response time for various input overdrives - positive transition

Figure 8. SO-8 package mechanical drawing

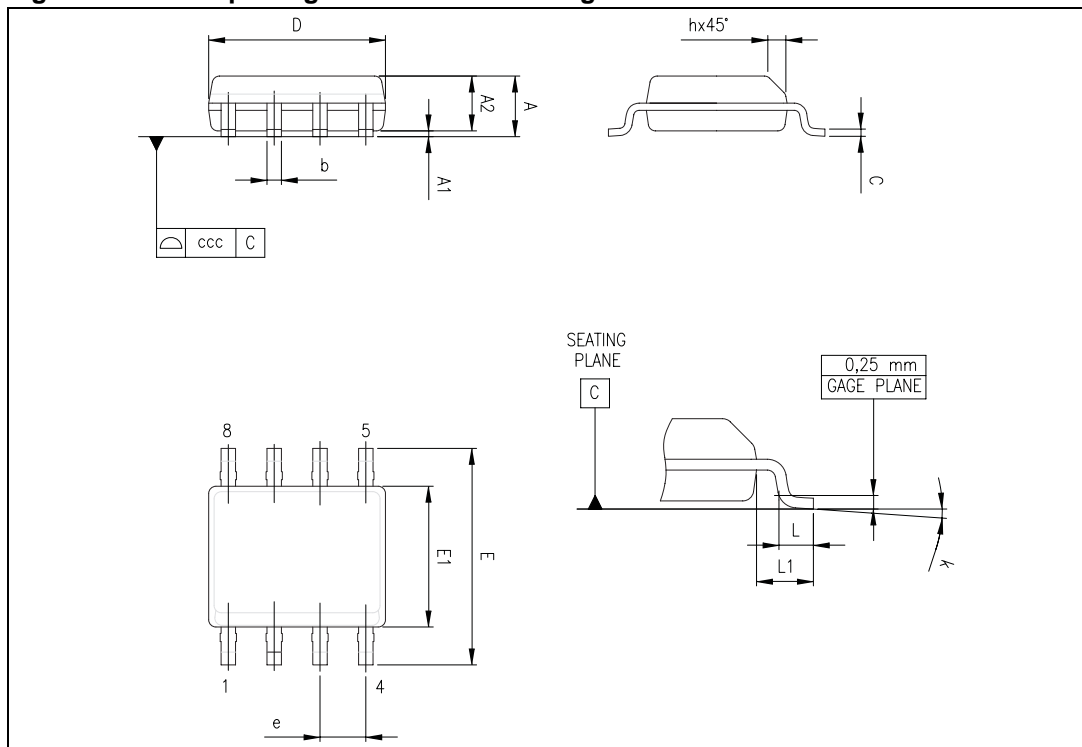
