




Forward Current vs. Collector **Dissipation Temperature Rating**




Light Current vs. Collector-Emitter Voltage Characteristics (Typical)





Sensing Position Characteristics (Typical)



Forward Current vs. Forward Voltage Characteristics (Typical)









Response Time vs. Load Resistance Characteristics (Typical)



Light Current vs. Forward Current **Characteristics (Typical)**




Light Current vs. Ambient **Temperature Characteristics** (Typical)
