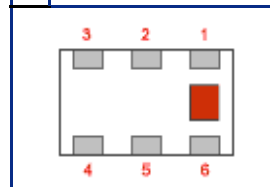

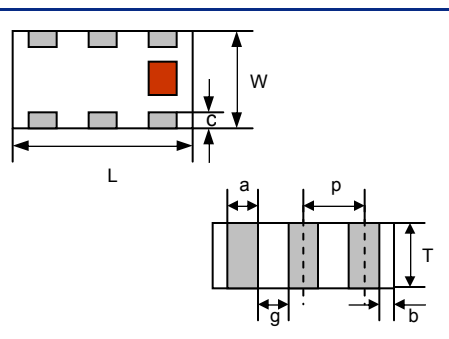

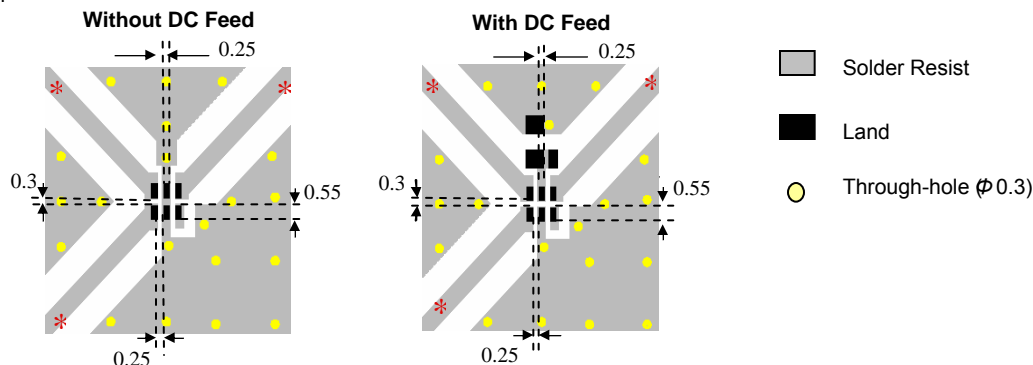


### Mounting Considerations

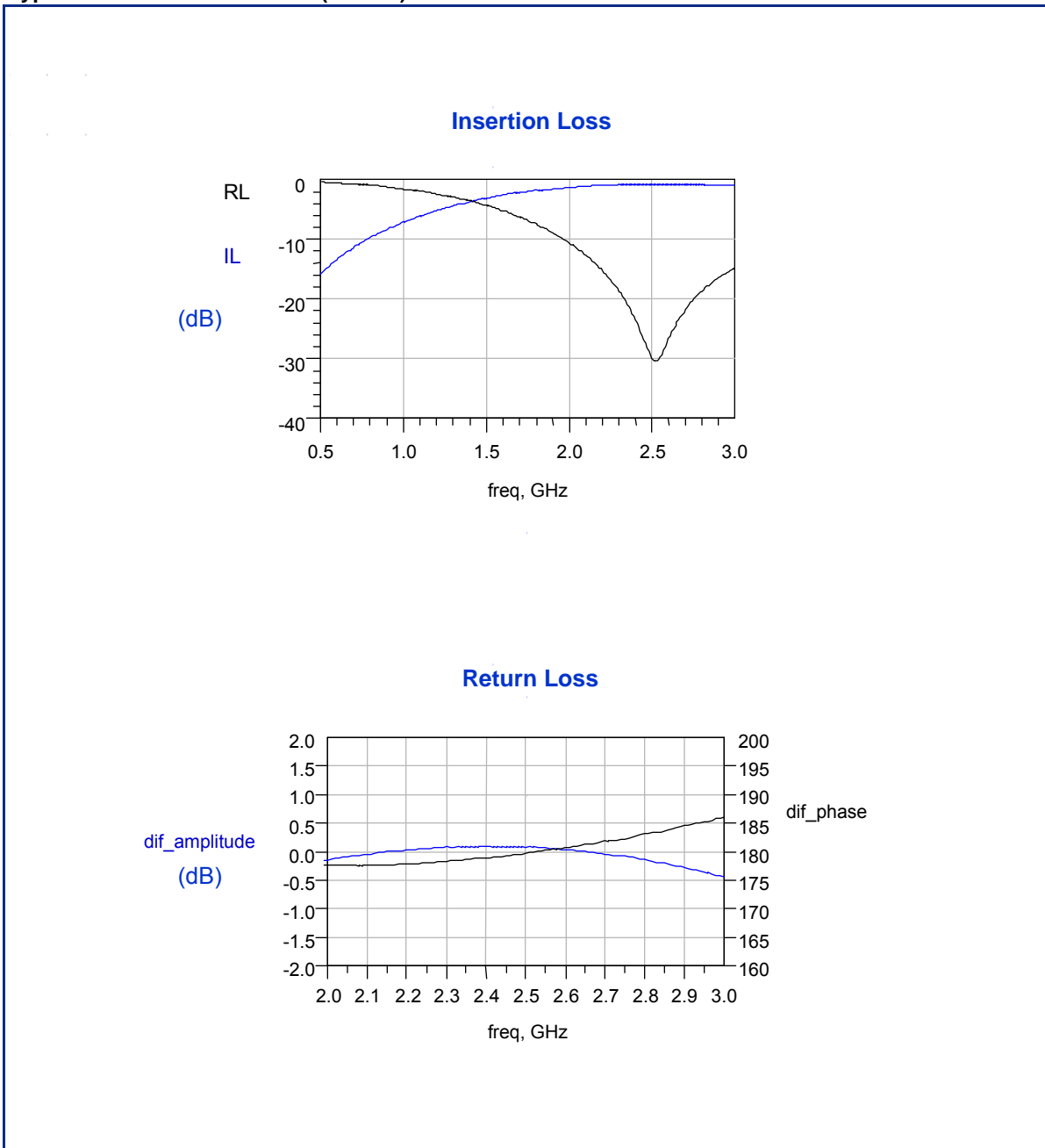
