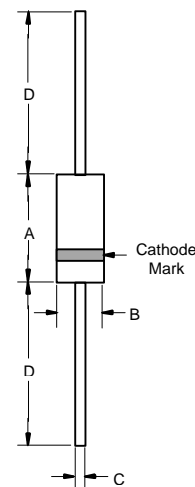

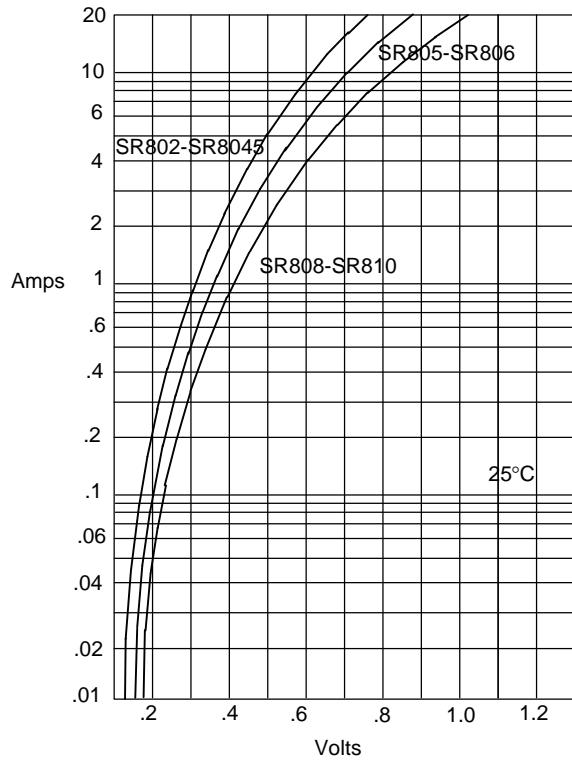

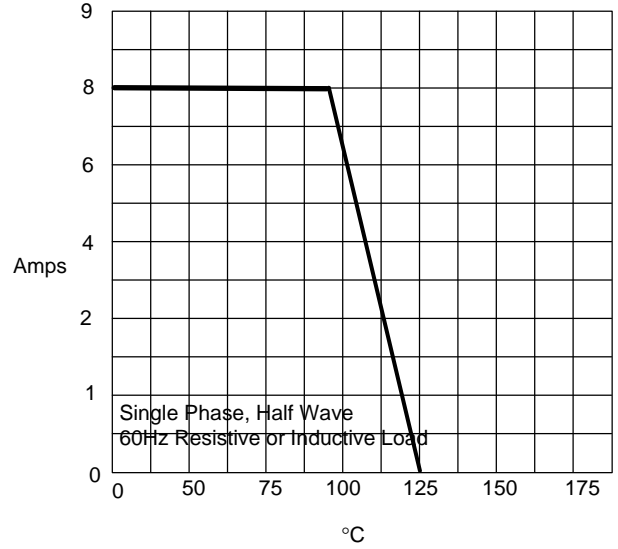

Typical Forward Characteristics



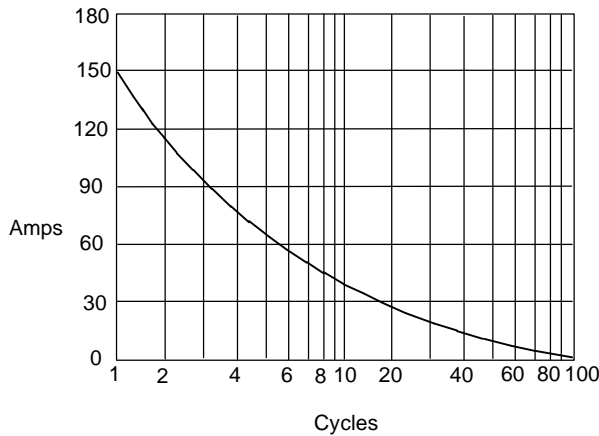
Instantaneous Forward Current - Amperes *versus*

Forward Derating Curve



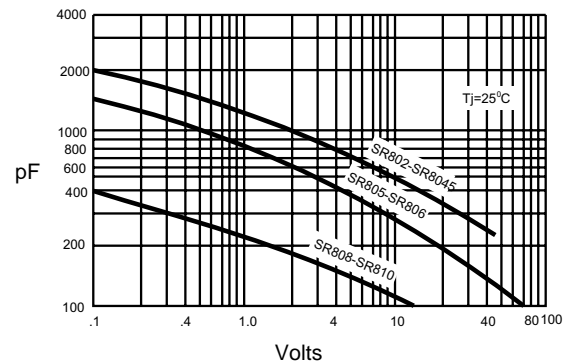
Average Forward Rectified Current - Amperes *versus*
