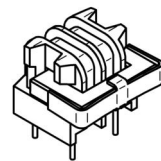

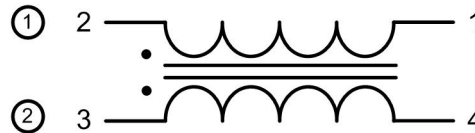
**B Recommended hole pattern: [mm]**

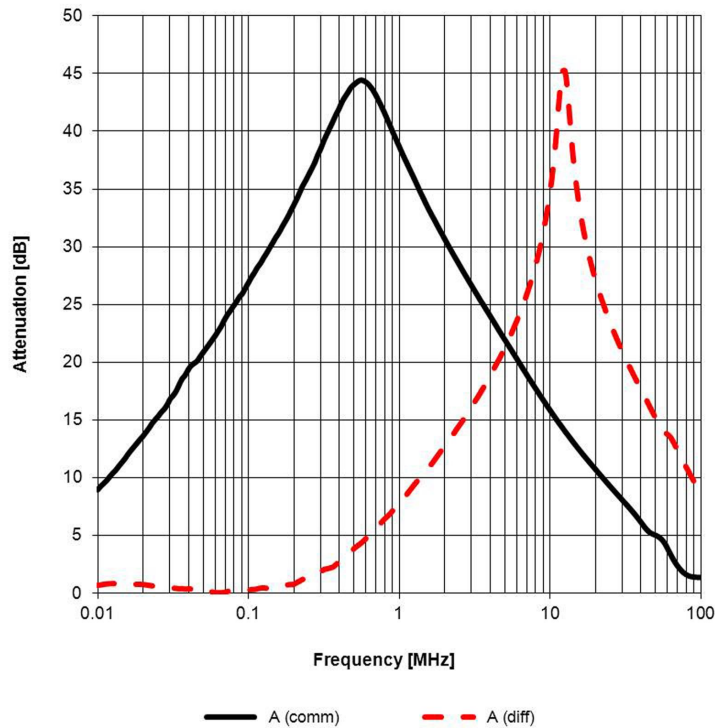

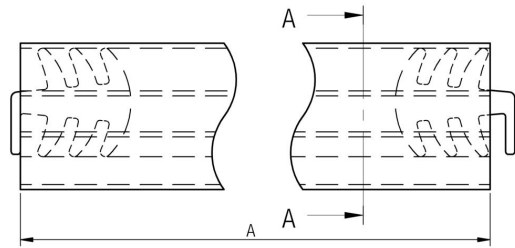
### F Typical Insertion Loss Characteristics:



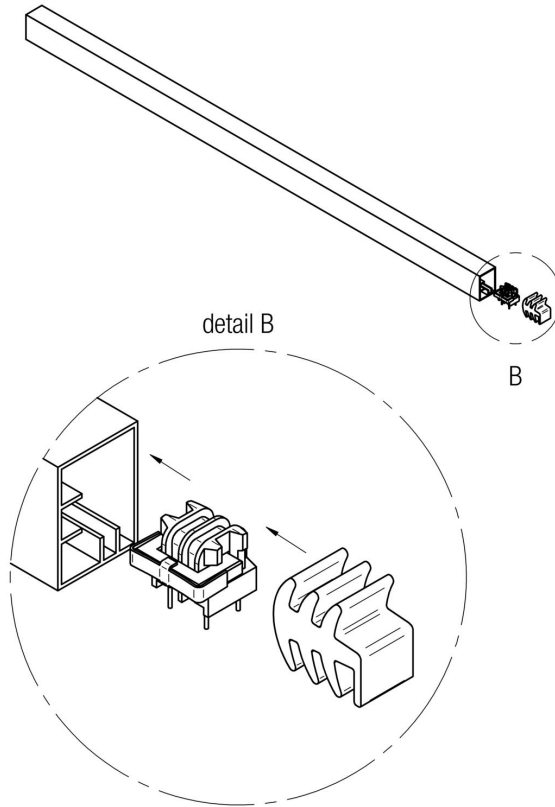
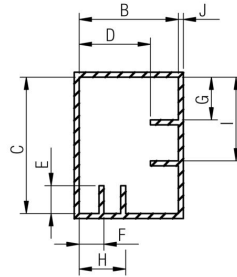


