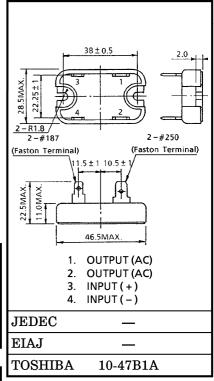

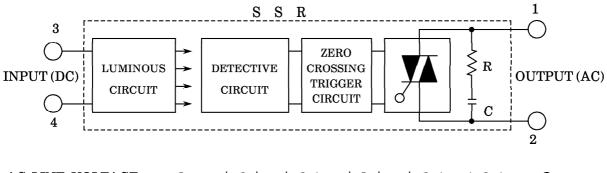

EQUIVALENT CIRCUIT



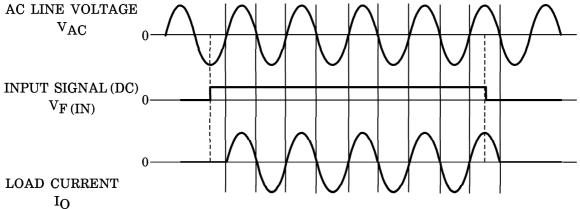
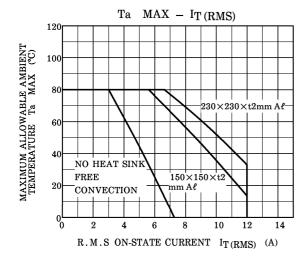
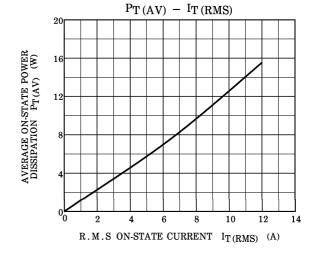
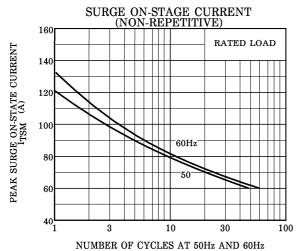


Fig. 1. ZERO VOLTAGE SWITCHING WAVEFORM
