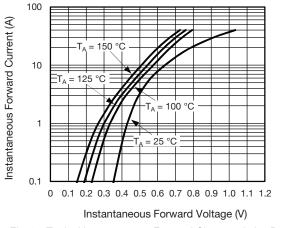




Fig. 3 - Typical Instantaneous Forward Characteristics Per Diode










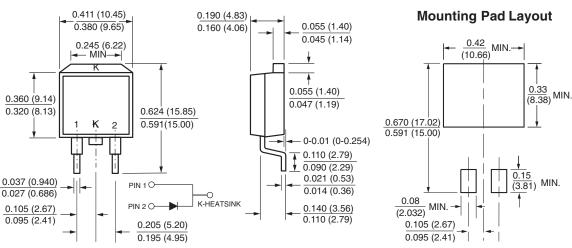


Fig. 6 - Typical Transient Thermal Impedance Per Diode
