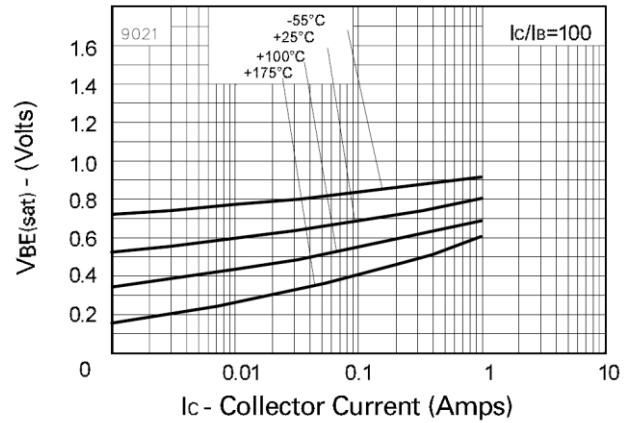

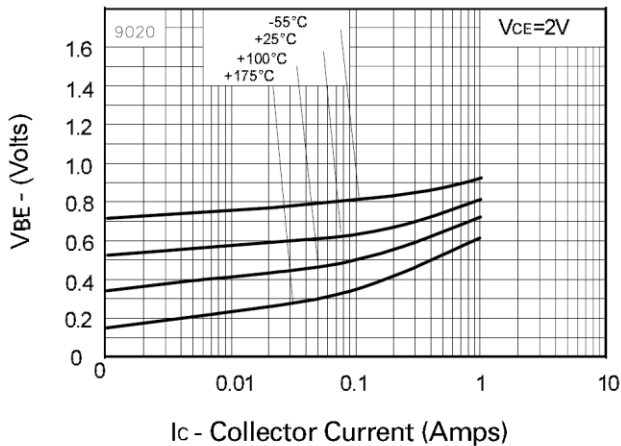
**VCE(sat) v IC**



**hFE v IC**



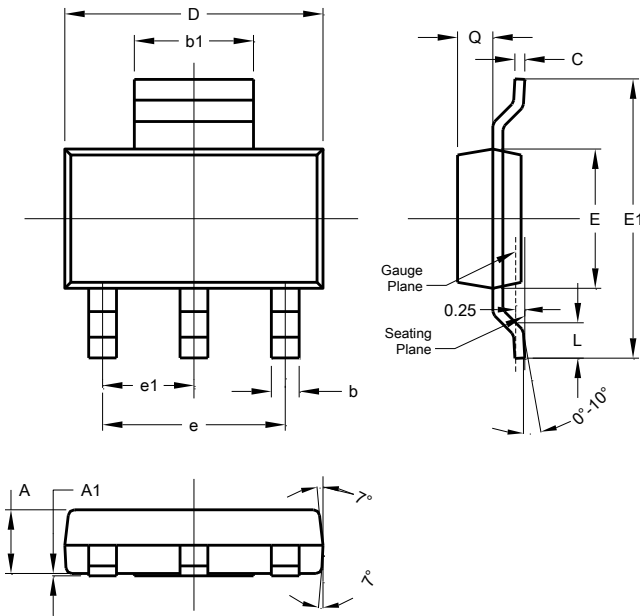
**VBE(sat) v IC**

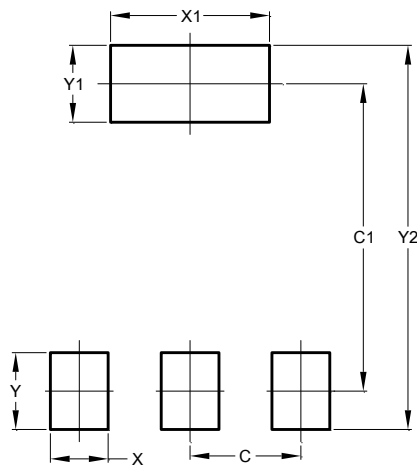
