# DESCRIPTION





# PACKAGE DIMENSIONS (UNIT: mm)










2. Test circuit for propagation delay time

3. Test circuit for common mode transient immunity










# TAPING SPECIFICATIONS (UNIT: mm)




# **USAGE CAUTIONS**

- 1. This product is weak for static electricity by designed with high-speed integrated circuit so protect against static electricity when handling.
- 2. By-pass capacitor of more than  $0.1 \,\mu$ F is used between V<sub>CC</sub> and GND near device. Also, ensure that the distance between the leads of the photocoupler and capacitor is no more than 10 mm.
- 3. Avoid storage at a high temperature and high humidity.



### Dependence of maximum safety ratings with package temperature




