


Figure 1. Static Characteristic




Figure 3. Base-Emitter Saturation Voltage Collector-Emitter Saturation Voltage




Figure 5. Switching Time




Figure 2. DC current Gain




Figure 4. Base-Emitter On Voltage




Figure 6. Safe Operating Area




Figure 1. Reverse Bias Safe Operating Area





Figure 2. Power Derating
