#### Dual 4-Input AND Gate

The TC74VHC21 is an advanced high speed CMOS 4-INPUT AND GATE fabricated with silicon gate C<sup>2</sup>MOS technology.


It achieves the high speed operation similar to equivalent Bipolar Schottky TTL while maintaining the CMOS low power dissipation.

The internal circuit is composed of 4 stages including a buffer output, which provide high noise immunity and stable output.

An input protection circuit ensures that 0 to 5.5 V can be applied to the input pins without regard to the supply voltage. This device can be used to interface 5 V to 3 V systems and two supply systems such as battery back up. This circuit prevents device destruction due to mismatched supply and input voltages.



- Pin and function compatible with 74ALS21





#### Input Equivalent Circuit

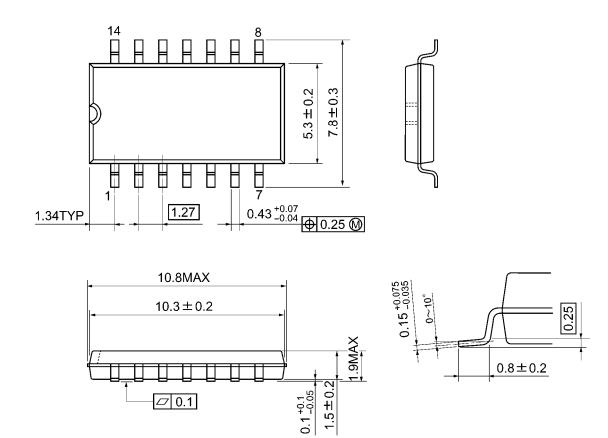



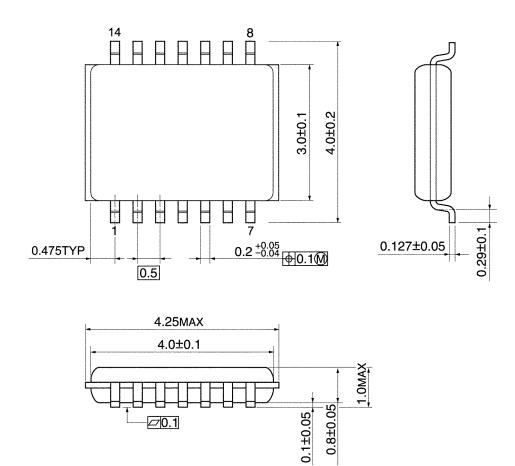
