The FSA2357 is a Double-Pole, Triple Throw (DP3T) multiplexer that routes three dual-channel sources of data or audio under the control of three select pins. Typical applications involve switching in portables and consumer applications, such as cell phones, digital cameras, and notebooks with hubs or controllers.




Figure 1. Analog Symbol
