
### **TEST CIRCUIT 1 AVALANCHE CAPABILITY**



### TEST CIRCUIT 2 SWITCHING TIME




### **TEST CIRCUIT 3 GATE CHARGE**






### DERATING FACTOR OF FORWARD BIAS SAFE OPERATING AREA




### TOTAL POWER DISSIPATION vs. CASE TEMPERATURE



#### FORWARD BIAS SAFE OPERATING AREA










### DRAIN CURRENT vs. DRAIN TO SOURCE VOLTAGE




### GATE TO SOURCE THRESHOLD VOLTAGE vs. CHANNEL TEMPERATURE




### DRAIN TO SOURCE ON-STATE RESISTANCE vs. DRAIN CURRENT




#### FORWARD TRANSFER CHARACTERISTICS




### FORWARD TRANSFER ADMITTANCE vs. DRAIN CURRENT




### DRAIN TO SOURCE ON-STATE RESISTANCE vs. GATE TO SOURCE VOLTAGE




R<sub>DS(m)</sub> - Drain to Source On-state Resistance - mΩ
