ELECTRICAL BLOCK DIAGRAM

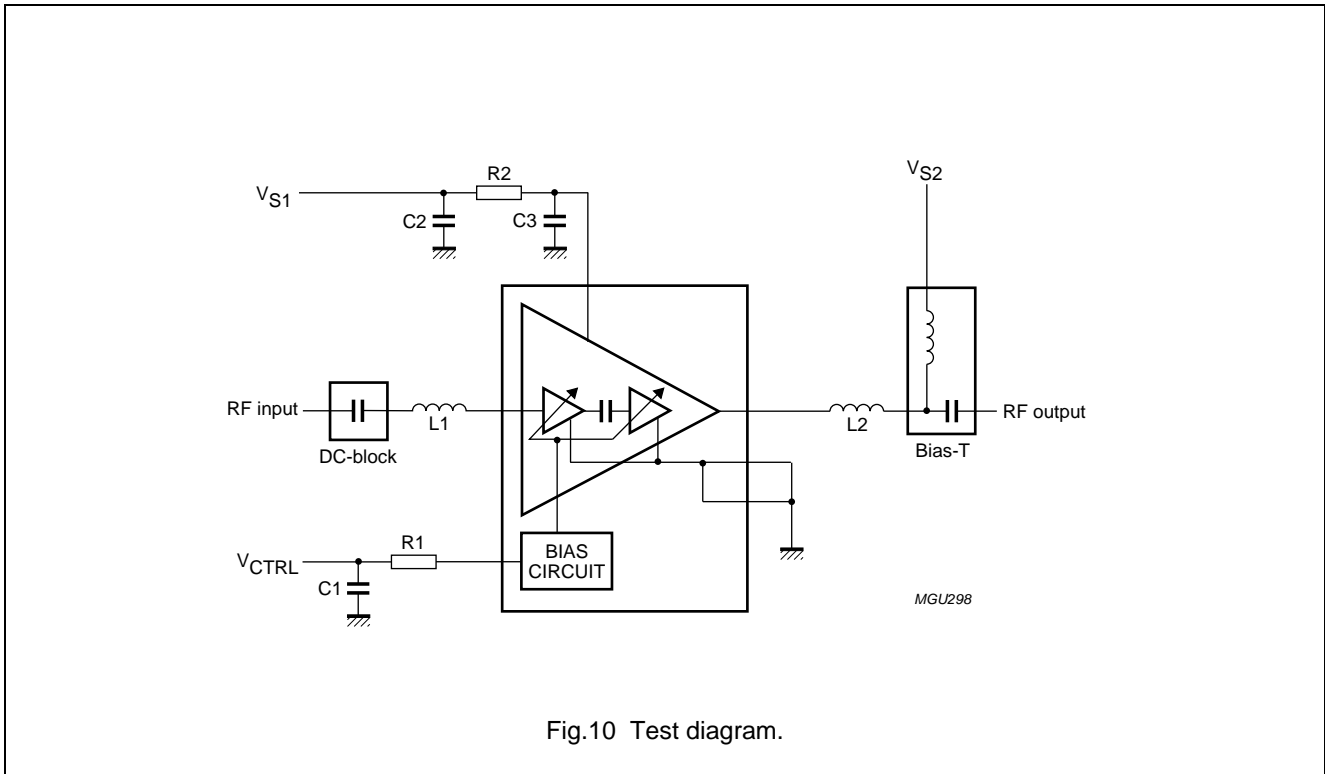


Fig.10 Test diagram.

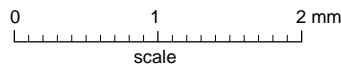
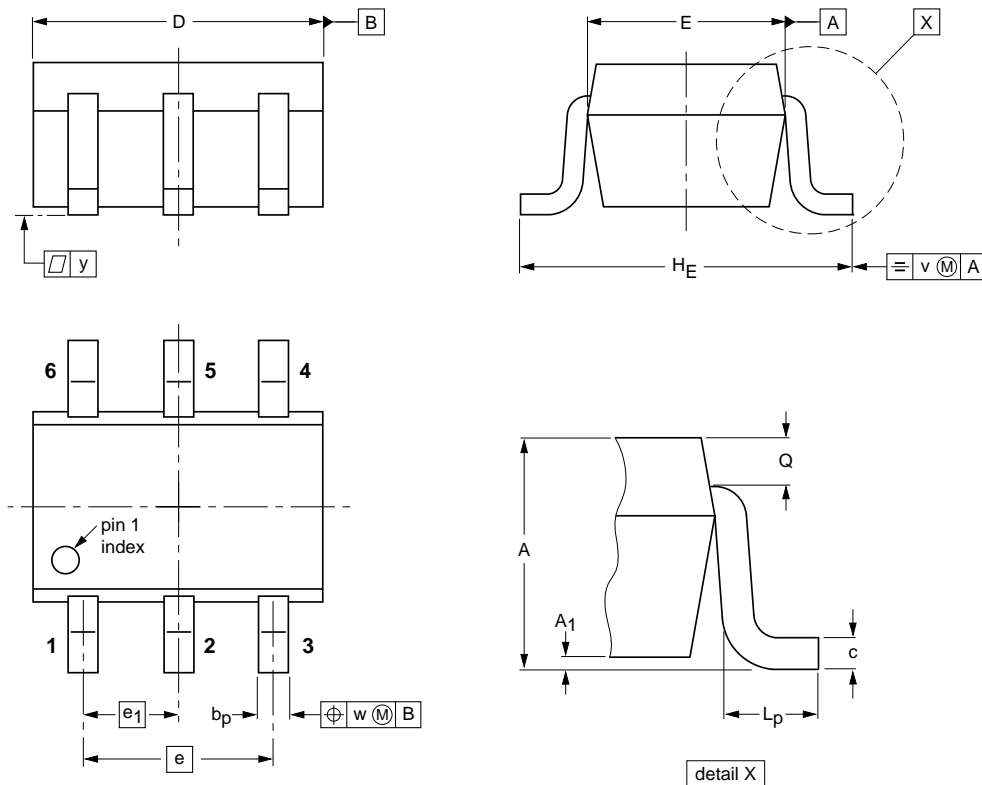
