










Figure 7 Pulse Derating Curve

Figure 8 Maximum Avalanche Power Curve, Per Element







Figure 9 Single Pulse Maximum Power Dissipation




t1, PULSE DURATION TIMES (sec) Figure 10 Transient Thermal Resistance


